Ownership history from documents, oldest first:

1st June 1895

Described as: Cottage, Bradwell

Formerly in the occupation of John Furniss but sold by David King (General Dealer) to Cheetham Cooper (Miner) for the sum of £34. Mortgage made with the Bradwell Independent Union Society.

Cheetham Cooper died 1st October 1915 leaving his estate to his wife Elizabeth.

(Background Information: Elizabeth was the daughter of William Middleton a Wool Hatter. On the 1881 census William was aged 62 and a widower, Cheetham and Elizabeth were aged 24 and 23 respectively and had a one year old son called Horatio W. Cooper. They are shown as living together on The Hills, Bradwell, but no specific property is indicated).

29th January 1920

Described as: Freehold cottage situated at Wall Head in Bradwell

Sold by Elizabeth Cooper (Widow) to

James Hartley (Boiler Fireman) for £130.

Conveyance document states property bounded toward the north by hereditaments belonging to Amanda Gent, to the South by hereditaments belonging to the vendor, to the east by executors of the late Robert Tanfield and on the West by the public highway known as Wall Head.

18th August 1937

Official Search in name of James Hartley

21st August 1937

Described as: O'er Gate situated at Wall Head in Bradwell

James Hartley (then living at 60, Lees Hall Avenue, Sheffield) sold property to

Mr Leslie Sammans (Master Lorry Driver) for £150.

Plans for extension dated 29th March 1939 drawn by John W. Blackhurst (FIAA) for Leslie Sammans Esq. Completion of works certificate dated 10th July 1940.

2nd May 1994

Mr Leslie Sammans died

His estate shared between David James Arthur Sammans of 56 Wyvern Gardens, Dore and

Rosemary Elizabeth Shaw of 3 The Firs, Smalldale, Bradwell.

4th August 1995

Land Registry 'The Cottage O'Ergate' by John & Louise Walliss.

Property renamed by 'Bedrock' by Mr & Mrs Walliss.

Assume property purchased in 1995 by Mr & Mrs Walliss.

Sold in 1999

to Linda Cutter who changed the name of the house from 'Bedrock' to 'Penallt Cottage'.

The name Penallt being the name of Linda's home village in Monmouthshire, South Wales. Having researched the history perhaps its now time to revert back to one of the original names the house was known by? In 2015 the name was changed but to Candlelight Cottage, a nod to the Nook across the road where it is believed candle were made in the 19th Century.
